## Primary Officer Positions:

- Treasurer
- Secretary

- All Committee appointments are subject to final approval by the Sponsoring Dealer. The Sponsoring Dealer's decision is final.
- The Sponsoring Dealer may nominate any member for any position. In this case, the Sponsoring Dealer takes precedence over any other nomination.
- Any nomination of a Sydney HOG Member to an Officer position must be:
  - In writing and signed by the Sydney HOG member nominee.
  - Endorsed in writing by any two (2) members of Sydney HOG Chapter.
  - Delivered to the Secretary no later than the Chapter meeting on the first Tuesday in November, one month prior to the Chapter Annual General Meeting (AGM) in December, at which the election for Primary Officer Positions is to take place if required.
- The Secretary will assess each nomination with the Sponsoring Dealer and advise the nominee of acceptance (or otherwise) in writing at the latest 1 week before the AGM.
- If there is only one nomination accepted by the Secretary for any Officer position, the nominee will be directly appointed, subject to final approval by the Sponsoring Dealer.
- If there is more than one accepted nomination for any Primary Officer position, a vote will be held at the AGM.
- If there is more than one accepted nomination to any other Officer position, the Sponsoring Dealer, the Director and the Primary Officers will decide the appointment immediately after the AGM.
